

**INTERDISTRICT AGREEMENT (IA)
BETWEEN THE PIERCE COUNTY SKILLS CENTER
AND CHIEF LESCHI TRIBAL COMPACT
FOR COOPERATIVE EDUCATIONAL SERVICES
2018-19 SUMMER SCHOOL ONLY**

This Agreement is hereby entered into by and between the Pierce County Skills Center, Puyallup, Washington, which is hereinafter referred to as "PCSC" and Chief Leschi Tribal Compact, Puyallup, Washington, hereinafter referred to as the "SENDING DISTRICT".

The purpose of this Agreement is to utilize interdistrict cooperation, authorized by RCW 28A.335.169, RCW 28A.225.250, and Chapter 392-135 WAC, to provide educational programs to students in the **SENDING DISTRICT** not otherwise available and to avoid duplications of specialized programs and facilities. These objectives will be achieved by enrollment and attendance in summer school programs only at or provided by PCSC.

This Agreement gives PCSC permission to access student information from the data resource management center of the **SENDING DISTRICT** to be used for mailings, health records, discipline records, Special Education/504 records for the purpose of accommodations and modifications, and other pertinent student information.

For the purpose of this agreement, it is understood that PCSC will claim up to .1 FTE for each summer school session a student attends.

The **SENDING DISTRICT** shall be responsible to:

- provide ancillary services for the student(s)
- provide all Special Education services for the student(s)
- administer state testing

This Agreement is for the 2018-2019 summer school year only and must be signed by the appropriate officials prior to PCSC confirming enrollment of any student(s).


