



RULES & REGULATIONS

- 1. PIERCE COUNTY CODE CHAPTER 14.08 WILL GOVERN PARK FACILITIES.
2. NO ALCHOLIC BEVERAGES ARE ALLOWED IN PARKS OPERATED BY PIERCE COUNTY PARK & RECREATION.
3. A facility use form must be completed to request use of the park.
4. No amplified musical instruments or public address systems may be used outside without written permission of Pierce County Parks and Recreation.
5. No park facility may be used for money making or fund-raising purposes without written permission of Pierce County Parks and Recreation.
6. Clean-up of facility is the responsibility of scheduled user.
7. Personal or catered barbecues may be used at the park and must be 20 feet from any structure.
8. Large groups will be assessed a special use fee of \$150-\$300+.
9. Insurance liability coverage will be required for large groups, naming Pierce County as additional insured
10. Any required damage/clean-up/conduct deposit will be returned upon surrender of the facility and equipment in the same condition as when rented.
11. Due to the effects of rain, wind, and other park patrons, the outdoor facilities may not be as clean as when routine maintenance was completed.
12. SMOKING IS PROHIBITED INSIDE ANY BUILDING.
13. Pets are kept on a leash no longer than 8 feet, or confined, and under control at all times except in designated rented areas.
14. Fees must be paid in full to book a reservation.
15. Reschedule/Change Fee: One change may be made at no charge (i.e. time, date, location).
16. Cancellations: Must be made in writing and must observe the following:
17. Pierce County Parks and Recreation has the right to cancel a reservation.
18. Any matter not covered here will be left to the discretion of the Superintendent of Recreation.
